ambulance as well, adding treatment right there at her house.

Paramedics Will Bannister and Pat Schmidt arrived shortly thereafter and immediately determined that Floyd was having an especially serious type of heart attack know as a STEMI.

They immediately began treating Floyd right there in his driveway, and Union County Fire Department first responders Dustin Lee and Travis Henry were also on the scene assisting.

Powell called two medical helicopter transport services, but because of the stormy weather that night, neither service was able to fly. So, Bannister and Schmidt drove Floyd over Blood Mountain to Northeast Georgia Medical Center in Gainesville.

The doctors at Northeast Georgia Medical found that Floyd had two main heart arteries completely blocked and a third about 78% blocked, requiring the placement of stents in a professionally created video in the two blocked arteries that night, followed by a stent in the

third artery a few days later. After waiting for a while at the hospital, Loretta said the doctor came out and said, and 911 Director Dyer headed "We've done all we can do. It's very, very grave at this point. He can't take any more. We can't do any more. It's in God's hands.

Added the doctor, "You can thank the paramedics. I was here, but the paramedics saved his life."

Union County Fire Chief and EMA Director David Dyer said Northeast Georgia also in attendance. Medical hosts a STEMI Summit annually, which showcases their most notable cardiac cases.

"At this Summit, they go over the latest and greatest the Northeast Georgia Medical Center is doing for cardiac issues and problems," said Dver.
