one of his 2015 arrests.

The investigation that followed Dr. Gowder's Fannin arrest was a joint operation between the Union County Sheriff's Office and several other agencies from the federal, state and local levels, including the DEA Tactical Diversion Squad, the DEA Digital Forensics Lab, the Georgia Drugs and Narcotics Agency, and the Cherokee County NC Sheriff's Office.

Along with Dr. James Heaton, five Gowder relatives were arrested on Feb. 4, 2016, as a result of that initial investigation: Mike Gowder, who at the time was CEO of Union General Hospital Inc.; Dr. David Gowder, Mike's brother; Gail Gowder, Mike's wife; Virginia Lou Harkins, Mike and David's sister; and Jamie Lee Harkins, daughter of Lou Harkins and niece of David and Mike.

The Union County Sheriff's Office served two search warrants that Feb. 4, one at Union General Hospital and the other at Dr. Heaton's office, in order to obtain both physical and digital files and patient records to further their investigation, according to authorities.

Initial charges for the six individuals arrested on Feb. 4, 2016, included:

Mike Gowder, three counts fraudulently obtaining controlled substance and one count of conspiracy to distribute controlled substance.

Dr. James Heaton, 41 counts of unauthorized distribution and dispensation of controlled substance.

Gail Gowder, two counts of fraudulently obtaining controlled substance.

Dr. David Gowder, seven counts of unauthorized distribution and dispensation of controlled substance, 36 counts of fraudulently obtaining controlled substance. Virginia Lou Harkins, two

counts of fraudulently obtaining controlled substance and one count of conspiracy to distribute controlled substance.

Jamie Lee Harkins, two counts of fraudulently obtaining controlled substance and one count of conspiracy to distribute controlled substance.

This year, three applicants were awarded various grant amounts, ranging from \$1,000 to \$5,000. The recipients this year were Roger Lampert with SMART Recovery, Shanna Prather with New Hope Counseling and Joe Dyer with Freedom Ministries. SMART Recovery

SMART Recovery stands for Self-Management and Recovery Training, and is a program that offers a safe place to discuss behavioral patterns, addiction triggers and any type of behaviors that might be selfharming or harmful to others.

All proceeds from the grant Lampert received will go toward assisting and aiding those who struggle with addiction and providing a stable learning environment for those individuals.

Lampert hosts SMART Recovery classes at the Red Cross Building in Young Harris on the second and third of each month, a 7 p.m. He also holds classes in Blairsville at the Haralson Memorial Civic Center on the first and third Mondays of each month at 7 p.m. New Hope Counseling is an office committed to the care of substance abusers and the necessary steps needed to begin the recovery process, with an emphasis on DUI offenders. Prather, administrator for New Hope Counseling, said that her grant would be used to assist those who are unable to pay for care, and to further extend the reach of the program to aid in the rehabilitation process for substance abusers throughout Union County. "We are a state-certified DUI education treatment provider," said Prather. "We also have a DUI school. Essentially what we do is take all people who struggle, but our specialty is DUI and anyone who struggles with substance abuse. "We have an indigent fund because a lot of people who struggle with substance abuse don't have the funds to get the treatment they need. "We do what we do because we love to help people. It's the greatest thing in the world. It doesn't even feel like a job.' Unlike SMART Recovery and New Hope Counseling, Freedom Ministries is a nondenominational, Christcentered recovery program for both men and women who are currently struggling or are recovering from drug and

The last item of official
