across the four counties.
"And it's our only alcohol-free fundraiser so it's more family-friendly, I guess you could say. So much is donated that we also raise a tidy sum for our operating budget.'

Regionally farmed, smoked rainbow trout from Holder's Trout Farm in Graham County, North Carolina, were served up along with baked beans, coleslaw, potato salad, cornbread, drinks and homemade desserts.

Usually, Moore sources the trout from a local hatchery to continue the support of the waterways within the HRWC which covers all rivers, creeks and lakes that flow into the Hiwassee River. However, due to some residual effects of the drought, Moore had to outsource.

"This year we weren't able to get our trout in Union County because last year's drought cut the supply of fingerlings available," said Moore. "Trout require cold, highly oxygenated, clean water. A small part of Union County is actually still in extreme drought and with the early hot temperatures; well it's a challenge for trout farms.

"Our fish came from Holder's Trout Farm located in the higher elevations of Graham County, North Carolina, but they don't sell to individuals, they are a wholesale retailer, and we were lucky they were able to accommodate our

Nevertheless, dozens upon dozens of local trout lovers came out to enjoy the good eats and fellowship with fellow waterway enthusiasts.

Patrick Fix, Mickey Cummings and Doug Towery helped grill up the mountains of delicious trout for patrons on a smoker loaned to the HRWC for the event by Ryan Talton, Union County High School Young Farmers teacher.

Of the countless that came out for the dinner, Joan Crothers, from Hiawassee, came out to the fundraiser with her friend, Brenda Hunt. According to Crothers, this is something she looks forward to every year.

"I've been coming to this practically every year they've had it," said Crothers. "The trout is always so good and I

dedicated to one specific purpose, rather it supports all of our major programs," said Moore. "They are water quality monitoring, education for both youth and adults and hands-on water quality and stream habitat improvements, like repairing eroding stream banks and fixing leaking septic

"We now have 62 active

water quality monitoring sites across the four-county area and E. coli is sampled at most of those during the summer months. We are always looking for more volunteers."

When Dills drove Cowan to the Dollar General, Cowan went inside and acquired a paring knife from merchandise available in the store, according to Lt. Osborn.

Cowan then went outside to tell Dills that his wife was shopping and would be finished soon, at which point he would pay Dills the bonding fee, according to Lt.

suspicious when Cowan went back into the store, because he maneuvered his vehicle to block in the only other vehicle in the parking lot, an orange 2009 Honda Fit sitting nearby,

according to Lt. Osborn. Unbeknownst to Dills, Cowan had gone back into the store to demand at knifepoint the car keys of the clerk on duty at the Dollar General, according to Lt. Osborn.

When Cowan once more returned to the parking lot, he saw that Dills had blocked in the car he was about to steal, and according to Lt. Osborn, Cowan first cranked up the Fit, then approached Dills and slashed him multiple times.

Cowan was able to maneuver the stolen car around Dills' vehicle, and he drove off, according to Lt. Osborn.

In the meantime, Dills drove himself to the hospital with lacerations to his arm, and medical workers contacted the sheriff's office upon his arrival, according to Lt. Osborn.

The sheriff's office also received a 911 call from the Dollar General, according to Lt. Osborn.

UCSO investigators tracked Cowan to Jackson County, where Cowan connected with his wife, according to Lt. Osborn.

Investigators just missed Cowan in Jackson County, though they continued to search for Cowan in other areas he was known to frequent, according to Lt. Osborn.

The big break in the manhunt came when a family friend called in a tip that Cowan was staying at a motel in Marion, Illinois, according to Lt. Osborn.

That family friend knew that Cowan was wanted out of Georgia thanks in part to the widespread media attention garnered by the Sunday, April 23, UCSO Facebook post containing a "be on the lookout" for Cowan.

While still on the scene with Cowan last Wednesday, Marion police contacted the

Union County Sheriff's Office, and investigators drove the seven hours to Marion to interview Cowan, according to Lt. Osborn.

Cowan confessed his crimes to both Marion authorities and UCSO investigators, according to Lt.

It was determined after his arrest that Cowan had stolen a North Carolina license plate and swapped it out for the one that belonged with the Honda Fit, according to Lt. Osborn.

The Fit was recovered at the motel in Marion, according to Lt. Osborn.

Cowan and his wife had been checked in to the motel in Marion under false names since Tuesday of last week, according to Lt. Osborn.

Currently, Cowan faces charges of two counts aggravated assault, one count theft by taking, one count armed robbery, one count terroristic threats, and one count false imprisonment, all felonies, according to Lt.

Dills and the Dollar General clerk were doing well at press time Monday, according to Lt. Osborn.
