OPPORTUNITY TO COMMENT ON THE FOREST HEALTH STEWARDSHIP PROJECT

The Chattahoochee National Forest, Blue Ridge Ranger District, is preparing an environmental assessment (EA) for the Forest Health Stewardship Project. The goal for this project is to improve forest health in immature, over-crowded, predominately pine stands in order to lower the risk of insect and disease infestation (particularly southern pine beetle) and reduce susceptibility to damaging wildfire. The project will achieve this goal through commercial and non-commercial thinning that favors native tree species. The proposed project is an activity implementing a land management plan and is subject to pre-decisional objection process at 36 CFR 218 Subparts A and B.

How to Comment and Timeframe

The opportunity to comment ends 30 days following the date of publication of this legal notice in the North Georgia News and The News Observer. Only those who submit timely and specific written comments §218.2 regarding the proposed project or activity during a public comment period established by the responsible official are eligible to file an objection §218.24(b)(6). For issues to be raised in objections, they must be based on previously submitted specific written comments regarding the proposed project or activity and attributed to the objector. The publication date of the legal notice in the newspaper of record is the exclusive means for calculating the time to submit written comments on a proposed project or activity. The time period for the opportunity to comment on a proposed project or activity to be documented with an environmental assessment shall not be extended. It is the responsibility of all individuals and organizations to ensure that their comments are received in a timely manner.
